# Message from USATF Adirondack President Bill Quinlisk

I attended the Electric City 5 Miler Saturday March 13<sup>th</sup> and have to say it was terrific to see so many USATF athletes back out on the race circuit! While things are certainly not back to normal, it was a great event nonetheless; kudos to the AREEP Staff for giving our members a chance to compete in these challenging times.

It appears we might be turning the corner on the pandemic, so it is a good time to remind clubs and members to renew their 2021 memberships. The new USATF national office membership renewal system can be challenging. The new system is called "USATF Connect". We recommend watching the training video on the USATF national website before you try to join or renew. Your membership starting point can be found here.

With the new system, anyone wanting to renew their membership will have to first migrate their previous data over to the new USATF Connect system. If mistakes are made, it can be difficult to back-track. I know; it happened to me. I found help through the USATF national office "Contact Us" link. It can also be found by going to <a href="www.usatf.org">www.usatf.org</a> and scrolling down to the very bottom of the home page and clicking on the "Contact Us" link. Fill out the contact form with as much information and explanation of the problems you are having with the system and what you are trying to accomplish. The national office staff has been surprisingly responsive to these requests. I discovered that one of the main difficulties with the new membership renewal process has been individuals who have used old web bookmarks or search engine URLs that lead them to the older USATF "Legacy" webpages. This is a bad move. Use the new web platform membership links provided above.

The Adirondack LDR Grand Prix leadership will consider extensions on GP registration for this year's Grand Prix for runners having difficulty navigating the membership renewal process. This will be done on a case-by-case basis. Just contact the LDR Committee at LDR@adirondack.usatf.org and explain your difficulties. In the meantime, don't forget to register for the Schenectady Firefighters' Run 4 Your Life 5k and run the race!

## **Track & Field Update**

Hopefully everyone has seen the exciting news about the <a href="Empire State Track & Field Classic">Empire State Track & Field Classic</a> to be held July 24, 2021 at SUNY Cortland. This meet will serve as the <a href="New York State Championship">New York State Championship</a> for the four (4) USATF Associations (Adirondack, Long Island, New York and Niagara) within the state of New York. The top three finishers at the 2021 USATF Adirondack Outdoor Track & Field Championships will qualify to compete.

Due to the current lack of outdoor facilities, we do not yet have a date for the Adirondack Association event, but we expect that to change is the high school outdoor seasons get underway. We will announce a date and location as soon as it is finalized. We hope to send a strong contingent of ADK athletes to Cortland to represent our Association!

### **Hall of Fame Nominations**

The Greater Capital Region Track, Field and Cross Country Hall of Fame is accepting candidates for its fourth class of inductees and has decided to combine the third and fourth classes in one ceremony in the fall of 2021.

Due to the pandemic, inductions for the third class had to be postponed in September. The committee recently decided that a tentative rescheduled date for the spring of 2021 would not be practical, either.

Eligible candidates include track and cross county standouts, road racers, coaches and contributors whose achievements occurred primarily in the Capital Region. Nominees must be at least five years removed from high school, but need not be retired from the sport. Nominations will be accepted through April 15. Nomination forms are available at the <a href="https://example.com/hall/swebsite">hall's website</a>.

## **Event Sanctioning**

A USATF sanction is an official designation issued by USATF, through a local Association, which approves and licenses the holding of a competitive track & field, long distance running or racewalking event in the United States. The sanction is also a contract, which evidences the event's commitment to follow national and international rules and regulations of the sport and to provide a safe environment for the participants and spectators. Once the event has satisfied the sanction requirements, the event's application for sanction is approved.

The benefits of sanctioning your event include increased prestige, liability insurance, sport accident insurance for athletes, calendar coverage, records and dispute resolutions.
